Other Ingredients: Aqua, Propanediol, Hydroxyethyl Urea, Glycerin, 1,2-Hexanediol, Gellan Gum, Butylene Glycol, Hydroxyacetophenone, Calcium Chloride, Polyglyceryl-10 Stearate, Hydrogenated Lecithin, Sucrose Stearate, Caprylhydroxamic Acid
